• Material of gloves

- **Penetration time of glove material** The exact break through time has to be found out by the manufacturer of the protective gloves and has to be observed.
- For the permanent contact in work areas without heightened risk of injury (e.g. Laboratory) gloves made of the following material are suitable: Nitrile rubber, NBR
